### Your Ministry to Jehovah's Witnesses and Mormons

This summer, we witnessed with approximately 150 other Christians to thousands of Mormons attending the LDS Church's "Mormon Miracle Pageant" — an annual reenactment of Joseph Smith's First Vision held in Manti, Utah. I was excited that my husband Bruce and our baby Alicia were able to join us in street witnessing for the first time. They witnessed to Mormons by handing out "10 Commandments" coins from Way of the Master along with our new business card tract for Mormons called, "**Are you forgiven of ALL of your sins?**" Rob and Doug also joined our team this year with their "**Is the Mormon Jesus the same Jesus of the Bible?**" sign that sparked numerous conversations with Mormons each evening, and I also conversed with many LDS who took the new business card tracts we developed for this year's outreach.

One of the best conversations I had was with a young Mormon gal named Emily. When she approached me to request copies of my business card tracts, I asked her if she would like to know how to be forgiven by God. She said, "yes!" and I proceeded to share the differences between the counterfeit "gospel" of Mormonism and the true Biblical Gospel. Please pray for her salvation.

In addition to handing out tracts, many ladies witnessed by participating in a display of the **34 wives of Joseph Smith**. Mormons were shocked to learn that Joseph Smith married **10 teenagers (including two 14 yr olds), 11 wives of living husbands**, a pair of sisters, and a mother and a daughter. This opened the door to explain how Joseph Smith could not qualify to be God's prophet and that we should only trust in Jesus.
